following reasons: (1) mistake, inadvertence, surprise, or excusable neglect...; (2) newly discovered evidence...; (3) fraud... misrepresentation, or other misconduct of an adverse party; (4) the judgment is void; (5) the judgment has been satisfied... or (6) any

other reason that justifies relief. Fed.R.Civ.P.

60(b). A. Rule 60(b)(1) is only available to set aside a judgment for "mistake, inadvertence, surprise, or excusable neglect." *Id.* On a motion under this section of the rule, the Court considers "whether any reasonable person could agree with the

district court that the standard for granting or denying relief has been satisfied." *Bracey v. Grondin*, 712 F.2d 1126, 1129 (5th Cir.1983); see also *Keegel v. Key West & Caribbean Trading Co., Inc.*, 627 F.2d 372, 373 (D.C.Cir.1980). Plaintiff argues that Defendant Sankara's failure to

respond timely to the complaint raises the "mistake" exception to the default judgment because it was surprised by the complaint.

However, in the case of a complaint filed through pro se service, "there must be something more than mere surprise or good cause to excuse

delay in filing a responsive pleading."

Huff v. Metropolitan Life Ins. Co., 675 F.2d 119, 122 (6th Cir.1982)

(holding that a district court did not abuse its discretion in refusing to set aside a default judgment even though the pro se plaintiff had not been served in a timely

manner and the
defendants had no idea
they were being sued);
